**Like schools world-wide, NDIZ spent the entire school year battling the COVID-19 pandemic. Even though the main focus was on supporting students and teachers as they moved back and forth between in-person and virtual learning, NDIZ had several accomplishments. An Executive Director search was completed and a new ED was onboarded. In addition, one part time staff member transitioned to work with another zone full time. NDIZ formed a Teachers' Council and met 7 times, and the Board of Directors convened 11 times. The zone fundraised and received a Broad Center and RootED grant, and fees were successfully collected from all schools in January 2021. Finally, NDIZ hired a new accountant and transitioned banking operations from Bank of America to First Bank.**
